ARTICLES OF INCORPORATION
OF
TRAFFIKTEK, INC.

The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, does hereby adopt the following Articles of Incorporation:

ARTICLE I - NAME

The name of the corporation is TRAFFIKTEK INC.
2536 COUNTRYSIDE BLVD., SUITE 200, CLEARWATER, FL 33763

ARTICLE II - DURATION

The duration of the corporation is perpetual.

ARTICLE III - PURPOSE

The general purposes for which the corporation is organized are the following:

- A. To engage in and transact any lawful business for which corporations may be incorporated under Florida General Corporation Act. No other purpose limits this general purpose in any way.
- B. To do such other things as are incidental to the purposes of the corporation or necessary or desirable in order to accomplish them.

ARTICLE IV - CAPITAL STOCK

The aggregate number of shares, which the corporation is authorized to issue, is 50,000,000 shares of common stock. Such shares shall be of a single class and shall have \$.00001 par value.

ARTICLE V - INITIAL REGISTERED OFFICE AND AGENT

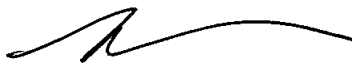

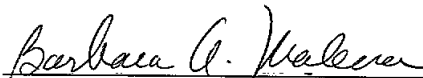

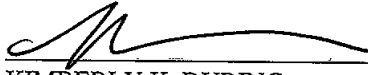
