#### DURATION

The duration of the Corporation is perpetual.

#### ARTICLE IV

be entitled to one vote for each share on all matters on which shareholders have the right to vote. The Corporation, to the extent permitted by law, shall be entitled to treat the person in whose name any share or right is registered on the books of the Corporation as the owner thereto, for all purposes, and except as may be agreed to in writing by the Corporation, the Corporation shall not be bound to recognize any equitable or other claim to, or interest in, such share or right on the part of any other person, whether or not the Corporation shall have notice thereof.
