



TO THE ARTICLES OF INCORPORATION OF

Pursuant to the provisions of Section 607.1006 of the Florida Statutes, the undersigned corporation adopts the following Articles of Amendment to its Articles of Incorporation.

1. The name of the corporation is SUAREZ FIRE SYSTEMS, INC.
2. The following amendments of the Articles of Incorporation were duly adopted by the stockholder and the Board of Directors of the corporation in the manner prescribed by the Florida Business Corporation Act:
