



ARTICLE 1: CORPORATE NAME: The name of this corporation is JED Enterprises Two, Inc.

ARTICLE 2: PRINCIPAL OFFICE: The street address of the initial principal office of this corporation is 2901 Clint Moore Road, Boca Raton, Florida 33496.

ARTICLE 3: MAILING ADDRESS: The initial mailing address of this corporation is 2901 Clint Moore Road, Boca Raton, Florida 33496.
