of

ARTICLE I. NAME AND ADDRESS

The name of this corporation is Get Interactive, Inc., and the address of the corporation shall be 6161 9th Street North, Suite 100, St. Petersburg, Florida 33703.

ARTICLE II. COMMENCEMENT OF CORPORATE EXISTENCE

In accordance with Section 607.167 Florida Statutes, the date when corporate existence shall commence is the date of subscription and acknowledgment of these Articles of Incorporation.

ARTICLE III. DURATION

This corporation shall exist perpetually, commencing on the date of *filing*.


ARTICLE X. INDEMNIFICATION


