

The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, does hereby adopt the following Articles of Incorporation:

ARTICLE I.. CORPORATION NAME.

The name of the corporation is Lawrence J. Siemer, P.A.

ARTICLE II. NATURE OF BUSINESS AND POWERS.

The general nature of the business to be transacted by this Corporation is to engage in any and all business permitted under the laws of the State of Florida. and the specific nature of the business is a law firm..

ARTICLE III. CAPITAL STOCK..

The maximum number of shares of stock that this Corporation is authorized to issue and have outstanding at any one time is 1,000 shares of common stock having a par value of \$.10 per share.

ARTICLE IV. TERMS OF EXISTENCE.

This Corporation shall have perpetual existence, commencing May 31, 2001.

ARTICLE V. REGISTERED AGENT AND INITIAL REGISTERED OFFICE.



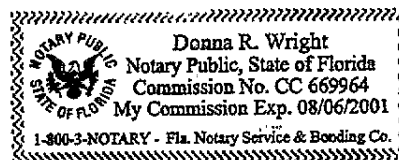


