ARTICLES OF INCORPORATION FOR SYNENTRE SERVICES, INC.

The undersigned sole incorporator, being a natural person competent to contract and desiring to form a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation:

ARTICLE 1. The name of the corporation is SynEntre Services, Inc.

ARTICLE 2. The duration of the corporation is perpetual.

ARTICLE 3. The principal place of business and mailing address of this corporation shall be 8000 South Orange Avenue, Orlando, FL 32809.

ARTICLE 4. The corporation is authorized to have outstanding at any one time 1000 shares of stock, at no par value.

ARTICLE 5. The corporation became effective on May 25, 2001.

ARTICLE 6. The corporation, initially, shall have one director, Frank L. Amodco, who shall serve in such capacity until the first annual meeting of the shareholders or until a qualified successor is duly elected.

ARTICLE 7. The corporation, initially, shall have the following officers who shall serve in the capacity indicated hereafter until the first meeting of the board of directors or until a qualified successor is duly elected: Frank L. Amodco, President; Frank L. Amodco, Secretary; and Frank L. Amodco, Treasurer.

ARTICLE 8. The Board of Directors shall not make, alter, or repeal any part or all of the Bylaws of the Corporation without the majority vote of the shareholders. The initial bylaws of the corporation are hereby incorporated into these Articles by reference.

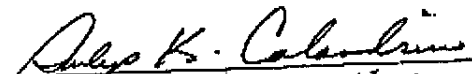

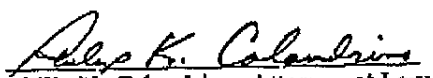
