"Article I: NAME

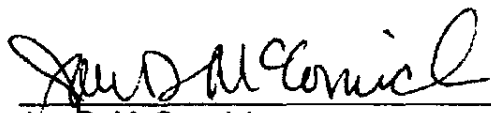
The name of this Corporation is Brant, Reiter, McCormick & Johnson, P.A."
