ARTICLES OF INCORPORATION

OF

TECHNIPOWER OF FLORIDA, INC.

TECHNIC PARTS I, the undersigned natural person, acting as incorporator of a corporation under the Florida Business Corporation Act, adopt the following Articles of Incorporation for such corporation:

ARTICLE I Name

The name of the corporation is TechniPower of Florida, Inc.

ARTICLE II Principal Office and Mailing Address

The address of the principal office of the corporation is 3450 Buschwood Park Drive, Suite 160, Tampa, Florida 33618, and the mailing address of the corporation is 16300 West Hansen Drive, New Berlin, Wisconsin 53151.

ARTICLE III **Purposes**

The purposes for which the corporation is organized are to engage in any lawful activity within the purposes for which a corporation may be organized under the Florida Business Corporation Act, Chapter 607 of the Florida Statutes.

ARTICLE IV Capital Stock

The aggregate number of shares which the corporation shall have authority to issue is Nine Thousand (9,000) shares, consisting of one class only, designated as "Common Stock," of the par value of One Dollar (\$1.00) per share.

ARTICLE V Right to Purchase Own Shares

The corporation shall have the right to acquire its own shares from time to time, upon such terms and conditions as the Board of Directors shall fix.
