ARTICLES OF INCORPORATION OF CYCLESCIENCE RACING, INC.

The undersigned hereby forms a Corporation under the following Charter of Articles of Incorporation:

ARTICLE I

The name of the corporation shall be CYCLESCIENCE RACING, INC.



ARTICLE II

The principal office and mailing address of the Corporation is 13975 U.S. Highway One, Juno Beach, Florida 33408.

ARTICLE III

The purpose of the Corporation is to engage in any activity or business permitted under the laws of the United States of America and the State of Florida.

ARTICLE IV

The Corporation shall have the authority to issue 500 shares of common stock with a par value of one dollar (\$1.00) per share.

ARTICLE V

The period of the Corporation's existence is perpetual.

ARTICLE VI
