ARTICLES I. NAME AND PRINCIPAL OFFICE

The name of this corporation is Ruth's Laundromat, Inc. and its principal office is located at 10582 St. Augustine Road, Jacksonville, Florida 32257.

ARTICLE II. DURATION

This corporation is to exit perpetually.

ARTICLE III. PURPOSE

This corporation is organized for the purpose of transacting any and or all lawful business.

ARTICLE IV. CORPORATE POWERS

This corporation shall have all and singular the following powers:
