**Article SIX**

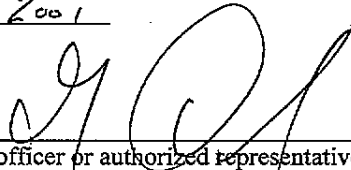
