ARTICLES OF INCORPORATION OF TRIM & WOOD WORKS BY JAMES MATTOX INCO

The undersigned, for the purposes of forming a corporation under the Florida general Corporation Act, hereby adopt the following Articles of Incorporation.

ARTICLE ONE NAME

The name of the corporation is Trim & Wood Works by James Mattox Inc.

ARTICLE TWO DURATION

This corporation shall commence existence as of the date of execution of these articles. The term of existence shall be perpetual.
