**ARTICLES OF INCORPORATION
OF
A BLIND AND DECORATING CENTER, INC.**

The undersigned, for the purpose of forming a corporation under the Florida Business Corporation Act hereby adopt the following articles of incorporation:

ARTICLE I

NAME

The name of the corporation is **A BLIND AND DECORATING CENTER, INC.**

ARTICLE II

DURATION

The term of existence of the corporation is perpetual.

ARTICLE III

PURPOSE

The corporation is formed to provide installation & manufacturing services and to transact any and all lawful business for which corporations may be incorporated under the Florida Business Corporation Act.




