This letter is in reference to the corporation, Bok Nyu, Inc. On 02/07/03 I went to the Department of Workman's Compensation to register. At that time I was informed that my company was no longer active. I called your office to find out why. I was told that I had not filed my 2002 USB form, and to reinstate, I would need to download a reinstatement form from Sunbiz.com and send in \$750.00. I let the individual know that I had not received anything telling me to send in this USB form. I did as instructed and sent the form and my check for \$758.75 on 02/08/03, via next day postal.
