ARTICLES OF AMENDMENT TO ARTICLES OF INCORPORATION OF <u>FANTASIA SEAFOODS, INC.</u>

Pursuant to Sections 607.1001, 607.1003 and 607.1006 of the Florida Business Opporation Act, the undersigned corporation, **FANTASIA SEAFOODS**, **INC.**, a Florida corporation (the "Corporation"), adopts the following Articles of Amendment to amend its Articles of Incorporation:

- 1. Name of the Corporation. The name of the Corporation is Fantasia Seafoods, Inc.
- 2. <u>Text of the Amendment</u>. The Amendment changes the name of the Corporation and the Purpose. Accordingly: Article I and Article III of the Articles of Incorporation are amended in their entirety to read as follows:

ARTICLE I - NAME

ARTICLE III - PURPOSE
