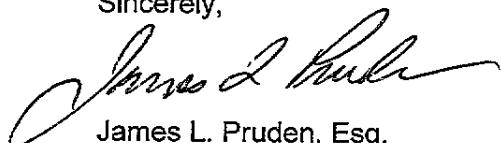

**Articles of Incorporation  
Of  
*WHITE BROADMAN, INC.***

**Article 1**

**Corporate Name**

The name of this corporation shall be "WHITE BROADMAN, INC. "

**Article 2**

**Principal Office and Mailing Address**

The principal office and mailing address of the Corporation is 415 S. Orange Street, Palm Harbor, Florida 34683.

**Article 3**

**Nature of Corporate Business**

The general nature of the business to be transacted by this Corporation shall be to engage in business for profit and it is organized for the following general purposes:

(a) To engage in any and all lawful business permitted under the laws of the United States and the State of Florida; and

(b) To make loans to or hold stock in other business entities, and enter into partnerships, limited partnerships, and joint ventures with other business entities.

**Article 4**

**Capital Stock**

This Corporation shall have authority, acting by its Board of Directors, to issue not more than **1,000 shares** of common class at **.001 PAR VALUE** per share, that have unlimited voting rights of one vote per share for the election of directors and with respect to other matters submitted to a vote of shareholders, and that are entitled to receive the net assets of the Corporation upon dissolution after payment of the Corporation's debts.

**Article 5**

**Term of Existence**

This Corporation shall have perpetual existence.

**Article 6**

**Effective Date of Corporation**

The Corporation shall commence business on May 18, 2001 along with the contemporaneous payment of not less than \$75.00 (seventy-five dollars) in value for the issuance of its shares.

**Article 7**

**Indemnification**

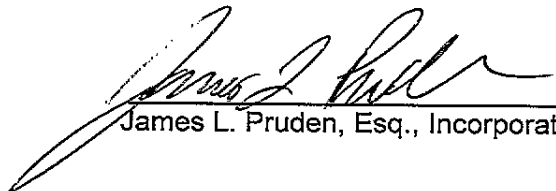

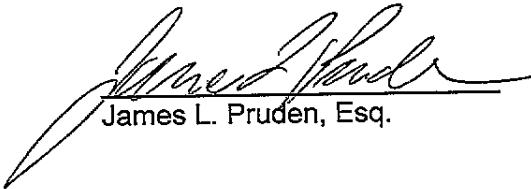
