The name of this corporation is: El Mariachi Staff, Inc.



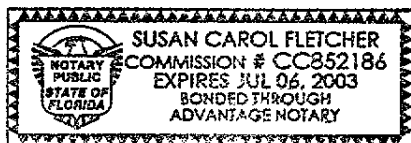


