ARTICLES OF INCORPORATION

ARTICLE I - NAME

The name of this corporation is Elijah Adams Home Improvement, Inc.

ARTICLE II - PRINCIPAL OFFICE

The mailing address of this corporation shall be:

ARTICLE III - PURPOSE




