# ARTICLES OF INCORPORATION OF RAYNOR SHINE TREE SERVICE, INC.

THE UNDERSIGNED, acting as sole incorporator of RAYNOR SHINE TREE SERVICE, INC., under Chapter 607 of the Florida Statutes, hereby adopts the following Articles of Incorporation for such corporation:


