**THIS IS TO CERTIFY that we, the undersigned, for the purpose of forming a corporation under the provision of Florida Statutes 1985, Chapter 607, and statutes amendatory thereof and supplementary thereto, do hereby make, subscribe, acknowledge and file these Articles of Incorporation, as we do certify that:**

**2. The major purpose of the corporation will be to engage in the business of private investigations.**

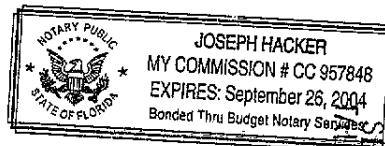
