ARTICLE I. CORPORATE NAME.

The name of this corporation is: Michael J. Barker, P.A.

ARTICLE II. ADDRESS OF PRINCIPAL OFFICE.

ARTICLE III. NATURE OF BUSINESS AND POWERS.

The general nature of the business to be transacted by this Corporation is to engage in the practice of law and any and all business permitted under the laws of the State of Florida.

ARTICLE IV. CAPITAL STOCK.

The maximum number of shares of stock that this Corporation is authorized to issue and have outstanding at any one time is One Hundred (100) shares of common stock.
