



ARTICLE I-Name

The name of this corporation is Dan Cober, DMD, P.A.

ARTICLE II- Principal Office

The address of the principal office and mailing address is 721 US Hwy 27 South, Sebring, Florida 33872.

ARTICLE III-Duration

This corporation shall have perpetual existence.

ARTICLE IV-Purpose

This corporation is organized for the purpose of engaging in the business of general dentistry and related professional services for which the shareholder(s) shall be licensed to render.

ARTICLE V-Capital Stock
