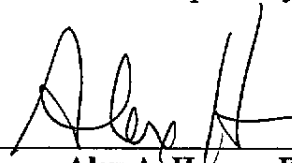

Article I  
Name

The name of the corporation is CORDERO, HANNA & ASSOCIATES, P.A., a Florida corporation.

ARTICLE II  
Duration

This corporation shall have a perpetual existence, unless dissolved according to law, commencing on the 24<sup>th</sup> day of May, 2001.

ARTICLE III  
Purpose

#### ARTICLE VII General Provisions

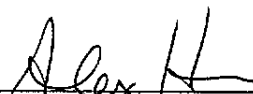
