ARTICLES OF INCORPORATION

OF

FOUND OBJECTS BY TWISTED SISTERS INCORPORATED

The undersigned, for the purpose of forming a corporation under the provisions of Chapter 607 of the Florida Statutes, hereinafter referred to as the Corporation, hereby agrees to the following:

ARTICLE I - NAME AND PRINCIPAL OFFICE

The name of the Corporation shall be Found Objects by Twisted Sisters Incorporated, a Florida corporation. The street address of the initial principal office of the Corporation and the mailing address of the Corporation is 1206 Manatee Avenue West, Bradenton, FL 34205.

ARTICLE II - PURPOSE AND POWERS

Section 1. The Corporation is formed for the purpose of engaging in any lawful activity or business for which corporations may be incorporated under the laws of the State of Florida.

Section 2. The Corporation may exercise all powers, rights and privileges conferred on corporations pursuant to the laws of the State of Florida.
