#### ARTICLES OF INCORPORATION

The undersigned subscriber to these Articles of Incorporation, a natural person, competent to contract, hereby comes to form a corporation under the laws of the State of Florida, Florida Statutes 607.001 et. seq., and the corporation so formed shall be for profit.

### ARTICLE I - NAME, OFFICE & MAILING ADDRESS

The name of the corporation shall be: PAUL'S OUTDRIVE REPAIRS, INC., located at 14355 SW 139th Court, Miami, Florida 33186.

#### **ARTICLE II - TERM OF EXISTENCE**

This corporation is to exist perpetually and shall commence at the time of filing these Articles.

## **ARTICLE III - NATURE OF BUSINESS**

The general nature of the business to be transacted by this corporation shall be the repair and installation of outdrives within and without the United States; as well as any other business now or in the future lawful in the State of Florida or any other jurisdiction where the corporation transacts business.
