We, the undersigned are desirous of forming a corporation under the laws of the State of Florida, such laws that are applicable to corporations for profit, and respectfully petition the Secretary of State for approval of such incorporation under the following proposed Certificate of Incorporation.

ARTICLE I

The name of this corporation shall be R. T. TRUCKING ENTERPRISES, INC. and its principal place of business shall be 1030 N. W. 151 Street, Miami, Florida 33169, and any location that the Board of Directors may deemed appropriated.

ARTICLE II

The general nature of the business, objects and purposes to be transacted, promoted or carried on by this corporation is to carry on any kind or type of business activity permitted under the law of the State of Florida and Federal Statutes, as amended.

This corporation is to have perpetual existence, commencing upon the approval by the Secretary of State of this Certificate of Incorporation.
