ARTICLES OF INCORPORATION
OF

The undersigned incorporation hereby forms a corporation under Chapter 607 of the laws of the State of Florida.

ARTICLE I

The name of the Corporation shall be: **TIMOTHY CROOKS, INC.**

ARTICLE II

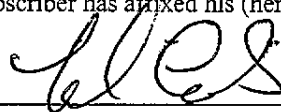

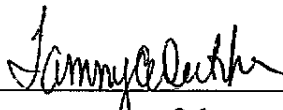

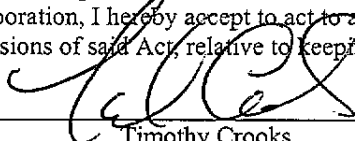
