# ARTICLES OF INCORPORATION OF SOCIALITE, INC.

The undersigned, acting as Incorporator of a corporation under the Florida General Corporation Act, adopts the following Articles of Incorporation for such corporation:

#### ARTICLE I

# NAME OF CORPORATION

The name of the corporation shall be:
