THE UNDERSIGNED subscribes to these Articles of Incorporation, a natural person competent to contract, hereby forms a corporation under the laws of the State of Florida.

**ARTICLE I - Name**

The name of the corporation is MAYO INVESTORS OF TAMPA, INC.

**ARTICLE II - Purpose of Corporation**

The corporation shall indemnify any incorporator, officer or director or any former officer, director or incorporator, to the fullest extent permitted by law.

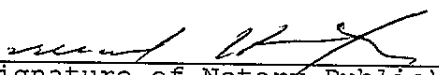
