

The undersigned for the purpose of forming a corporation under the Florida General Corporation Act, Florida Statutes, Section 607, hereby adopts the following Articles of Incorporation.

ARTICLE I - NAME

The name of the corporation is Dina Development Corporation.

ARTICLE II - DURATION

The term of this corporation is perpetual.

ARTICLE III - PURPOSE

This corporation is organized for the purpose of conducting and transacting any and all lawful business permitted under the laws of the State of Florida and the United States.




