THE UNDERSIGNED, being over the age of eighteen years, in order to form a corporation pursuant to the provisions of the Corporate Code, hereby certifies as follows:

FIRST
IDENTIFICATION

The name of the corporation, hereinafter referred to as the "Corporation," is **Go Ask Alice, Inc.**

SECOND
PERIOD OF EXISTENCE

The period during which the corporation shall continue is perpetual.

REGISTERED OFFICE AND REGISTERED AGENT / PRINCIPAL ADDRESS



INDEMNITY


