ARTICLE II - PURPOSE AND NATURE OF BUSINESS

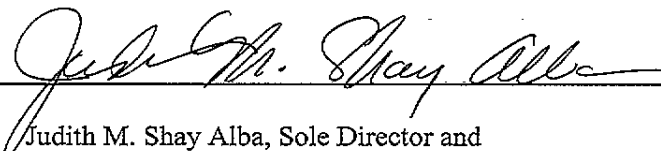
