**Articles of Incorporation of Jennifer Hart Griffis, P.A.**

The undersigned incorporator being duly licensed as an Advanced Registered Nurse Practitioner practicing nursing at an advanced level in the category of Certified Registered Nurse Anesthetist under the laws of the state of Florida, adopts these articles to form a corporation under the Professional Service Corporation and Limited Liability Act, F.S. Chapter 621, and other laws of the state of Florida.

ARTICLE I. NAME. The name of the professional service corporation shall be Jennifer Hart Griffis, P.A.

ARTICLE II. PURPOSE. The professional service corporation is formed to engage in every phase and aspect of the practice of Advanced Registered Nurse Practitioner practicing nursing at an advanced level in the category of Certified Registered Nurse Anesthetist. In addition, the corporation may invest the funds of the professional service corporation in real estate, mortgages, stocks, bonds, or any other type of investment, and own real and personal property necessary for the rendering of professional services.

ARTICLE III. PRINCIPAL OFFICE. The address of the principal place of business of this professional service corporation shall be 6400 NW 106th Place, #8, Alachua, Florida 32615, and the mailing address of the professional service corporation shall be P.O. Box 1992, Alachua, Florida 32616.

ARTICLE IV. CAPITAL STOCK. The number of shares of stock that this professional service corporation is authorized to have outstanding at any one time is 1000 shares of common stock, with a par value of \$1.




