

**ARTICLE I.**

**CORPORATE NAME**

The name of the corporation shall be:

**ARTICLE II.**

**PRINCIPAL OFFICE**

**ARTICLE III.**

**NATURE OF CORPORATE BUSINESS**

The corporation may engage in any business as allowed under the laws of the United States and under the laws of the State of Florida.




