### ARTICLE I.

#### ARTICLE IV.

#### General Powers

The corporation shall have power:

- (n) To make payments or donations or do any other act not inconsistent with law that furthers the business and affairs of the corporation.
- (o) To pay pensions and establish pension plans, pension trusts, profit sharing plans, share bonus plans, share option plans, and benefit or incentive plans for
  any or all of its current or former directors, officers, employees, and agents and for any
  or all of the current or former directors, officers, employees, and agents of its
  subsidiaries.
