
ARTICLE VIII

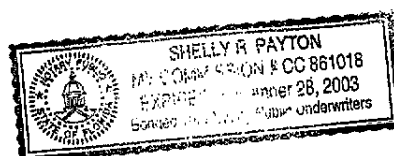
