ARTICLES OF INCORPORATION

OF

HOUSE REJUVENATORS, INC.

ARTICLE I -- NAME

The name of this corporation is HOUSE REJUVENATORS, INC.

ARTICLE II--DURATION

This corporation shall have perpetual existence commencing on the date of this filing of these Articles with the Department of State.

ARTICLE III - PURPOSE


#### ARTICLE IX-- INDEMNIFICATION
