ARTICLES OF INCORPORATION

OF

EXCEL TOWER SERVICES, INC.

I.

The name of the corporation is "EXCEL TOWER SERVICES, INC."

II.

The corporation is organized pursuant to the provisions of the Florida Business Corporation Act.

III.

The corporation shall have perpetual duration.

IV.

The corporation is a corporation for profit and is organized for the following purposes:

(a) To contract or perform for its own or other's account tower erection and repair and installation of equipment thereon;

(b) To engage in any lawful business or activity related thereto; and

(c) To engage in any other lawful business or activity for which corporations may be organized under the Florida Business Corporation Act.

V.

The corporation shall have the authority to issue not more than one thousand (1,000) shares of common stock having no par value with any and all limitations and rights to be established by the Board of Directors of the corporation.

VI.

The street and mailing address of the principal office of the corporation shall be:

VII.

and W. David Millsaps, the initial registered agent, who is an individual resident of Florida with his business address being identical with the business office of the corporation and who hereby states that he accepts the appointment of registered agent for the corporation.

VIII.

The initial Board of Directors shall consist of one (1) member who shall be:

IX.

X.

In addition to, but not in limitation of the general powers conferred upon the corporation by law, the Board of Directors of the corporation may, from time to time and at its discretion, distribute a portion of the assets to its shareholders out of the capital surplus of the corporation.

XI.

The corporation may, upon adoption of a resolution by its Board of Directors, purchase its own shares to the extent of unreserved and unrestricted capital surplus available for said purchase.

XII.

Any sale or other disposition of the shares of this corporation by its shareholders shall be subject to such restrictions as may be provided in the by-laws of the corporation.
