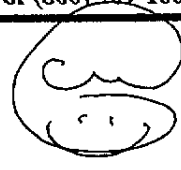

ARTICLE 1: NAME

This Corporation shall have perpetual existence.


ARTICLE 8 - REGISTERED OFFICE AND REGISTERED AGENT

These Articles of Incorporation shall be effective immediately upon approval of the Secretary of State, State of Florida.


