ARTICLE OF INCORPORATION

The undersigned incorporator hereby make, subscribe to, acknowledge and file these Articles of Incorporation for the purpose of organizing and incorporating a corporation for profit under the laws of the State of Florida.

ARTICLE I

The name of the corporation shall be:  
De'VISION CONCEPTS INC.

And it shall hereinafter be referred to as the "corporation".

ARTICLE II

The time and date on which corporate existence of this corporation shall begin is 12:01 A.M. (Eastern Standard Time) on the date of filling these articles with the Secretary of State, of the State of Florida, and this corporation shall have a continuous and perpetual existence thereafter.

ARTICLE III

The general purpose for which the corporation is initially organized are the transaction of any and all lawful business for which corporations may be incorporated under Chapter 607, Florida Statutes (1983), as amended.

ARTICLE IV

The aggregate number of shares which the corporation shall have authority to issue is 1000. The shares shall consist of one class only, and such class shall be known as "common" of the corporation. Each share shall have a par value of \$10.00 per share.

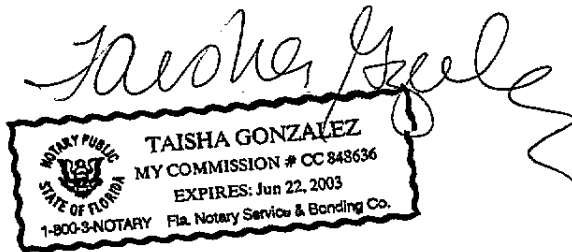
