Article I Name

The name of the corporation is WESTWARD INVESTMENTS, INC., a Florida corporation.

ARTICLE II Duration

This corporation shall have a perpetual existence, unless dissolved according to law, commencing on the 25th day of May, 2001.

ARTICLE III Purpose

This corporation is organized for the purpose of transacting any or all lawful business for which corporations may be incorporated under the Florida General Corporation Act.

ARTICLE IV Capital Stock

General Provisions

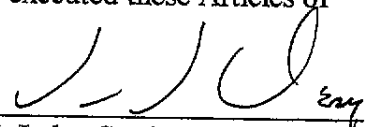
