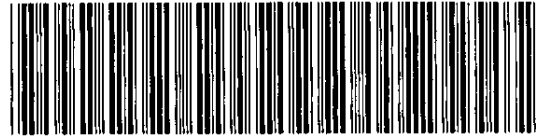


2. Date Dissolution Authorized: May 27, 2008
