OF

The undersigned subscriber to these Articles of Incorporation, J. Patrick Mahoney, being a natural person competent to contract, hereby acknowledges and files these ARTICLES OF INCORPORATION in the Office of the Secretary of State of the State of Florida in order to form a Corporation for profit under the laws of the State of Florida.

ARTICLE I

CORPORATE NAME

The name of this Corporation is THE ELECTRONIC HANDYMAN, INC. The principal office and mailing address of the corporation is 4390 Tamiami Trail North, Naples, Florida 34103.

DURATION

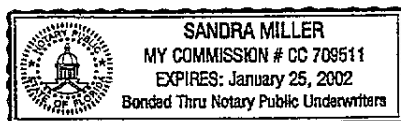




