OFFICERS

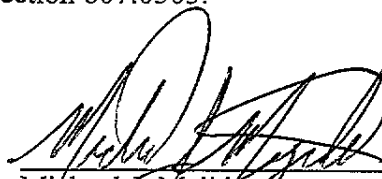
