ARTICLES OF INCORPORATION

OF

ARTICLE I - NAME

The name of this Corporation is PRIME MEDICAL SERVICES, INC.

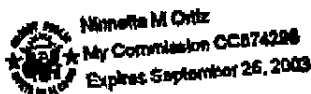
