ARTICLES OF INCORPORATION OF BROOKLYN PROPERTIES, INC.

ARTICLE I - NAME

The name of this corporation shall be Brooklyn Properties, Inc..



ARTICLE II - PURPOSE

The Corporation may engage in any activity or business under the laws of the United States and the State of Florida's General Corporation Act.

ARTICLE III - CAPITAL STOCK

The maximum number of shares of stock this corporation shall be authorized to have outstanding at any one time shall be **seven thousand five hundred (7,500)** shares of common stock of the par value of one dollar (\$1.00) per share, upon which there are no preemptive rights except to the extent specified by the By-Laws. This corporation will exist perpetually.

ARTICLE VI - PRINCIPAL OFFICE

The address of the initial register office is 155 E. Davis Blvd., Tampa, FL 33606 and the name of the initial registered agent is Daniel T. Parnassa located at the initial address. The registered office may be moved from time to time by action of the Board of Directors.

ARTICLE VII - BOARD OF DIRECTORS

ARTICLE XI - AMENDMENTS

These Articles of Incorporation may be amended in the manner provided by law. No contract or other transaction between this corporation shall in any way be affected or invalidated by the fact that any of the directors of this corporation are pecuniarily or otherwise interested in any contract or transaction of this corporation, provided that the fact that he or such firm so interested shall be disclosed or shall have been known to the Board of Directors or a majority thereof, and any directors of this corporation who are also directors or officers of such corporation, or who are so interested may be counted in determining the existence of a quorum at any meeting of the Board of Directors of this corporation, which shall authorize any such contract or transaction with like force and effect as if he were not such director or officer of such other corporation and not so interested.
