**ARTICLES OF INCORPORATION  
OF

I, the undersigned, for the purposes of forming a corporation under the Florida General Corporation Act, Chapter 607 Florida Statutes, do hereby adopt the following articles of incorporation:

**ARTICLE I**

The name of the corporation is: **First Capstone Financial Services, Inc.**

**ARTICLE II**

The duration of the corporation is perpetual.

**ARTICLE III**

General purposes for which the corporation is organized are:

1. To transact any lawful business for which corporations may be incorporated under the Florida General Corporation Act, Chapter 607 Florida Statutes, or engage in any other trade or business which can, in the opinion of the board of directors of the corporation, be advantageously carried on in connection with or auxiliary to the foregoing business.

2. To do such other things as are incidental to the foregoing or necessary or desirable in order to accomplish the foregoing.

**ARTICLE IV**

The aggregate number of shares of common stock which the corporation is authorized to issue is ONE THOUSAND (1,000.00). Such shares shall be of a single class, and shall be with a par value of \$0.01.

**ARTICLE V**

The street address of the initial registered office of the corporation is 816 Broad St., Jacksonville, Fl. 32202, and the name of its initial registered agent is DeAndrea L. Levias, and her address is 6291 Dickens Dr. Jacksonville, Fl. 32244. The principal office and registered address shall be 816 Broad St., Jacksonville, Fl. 32202 .

**ARTICLE VI**

The number of directors constituting the initial Board of Directors of the corporation is **TWO**

**ARTICLE VIII Amendments of Articles of Incorporation**

The shareholders shall have the power to adopt, amend, alter, change or repeal the Articles of Incorporation when proposed and approved at a stockholders' meeting, with not less than one half (1/2) vote of the common stock.

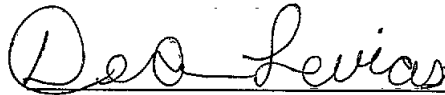
**ARTICLE IX Preemptive Rights**
