We would like to ask for a reinstatement and ask that you consider the extremely unusual circumstances surrounding our failure to pay the \$150.00 fee prior to May 1, 2002.

The President of this small closely-held corporation was stricken with cancer in mid January 2002. This cancer resulted in a long series of medical procedures lasting until late October 2002. A brief summary of those procedures follows:

- 1. Jan 23, 2002 PSA Test with Dr. Turner.

- 3. Mar 5, 2002 Examination by DR. Regan, Urologist.
- 4. Mar 28, 2002 Received C.A.T scan Imaging.
- 5. Apr 12, 2002 Biopsy of prostate, and admitted to hospital.
- 6. Apr 20, 2002 C.A.T. scan and bone density tests performed.
- 7. May 15, 2002 Admitted to H. Lee Moffitt Cancer Treatment Center.
- 8. During May and June 2002 Underwent first course of Chemo and Leuprol-acet treatments.
- 9. From June to October 24, 2002 Underwent a series of forty-eight (48) treatments of Radiation and Chemotherapy.
