Gentlemen:


I have reviewed all of my files in search of correspondence from the Department of State concerning the 2003 annual report/uniform business report. I have not received original nor subsequent notices to file.

I have found a couple of rather disturbing facts that bear on the subject of the Department's ability to capture and retain correct address information in their data base. My records for 2002 show that I supplied the department corrected addresses for my home and for the registered agent; the word Washingtonia was misspelled twice as Wahsingtonia.

When I moved to my current address at 8420 Southwind Bay Circle in September of 2002 I notified the Department that month. That update evidently did not get into the database, as I never received a 2003 annual report form/ uniform business report form. Nor did I receive any follow up notices of delinquencies. After one year of my notice to the Department I now have received the reinstatement notice as of last week. Interesting, the mailing address information was correct on the outside of the package. However, all of the addresses in the form were inaccurate and two of three addresses in the form were still misspelled; Washingtonia is listed as both Wahsingtonia and Weashingtonia. It is reasonable to expect that the Department sent me a notice but either misspelled the address and/ or sent it to the wrong address and the US Postoffice could not forward it.

In any event I am enclosing the completed "reinstatement document" including corrected addresses and a check for \$150.00 to cover the 2003 annual report fee. I trust my explanation and this information will allow you to continue the "active" status of MIH International.
